



Sandcreek 6 LLC. Agreement to Program Policies

1. We are guests at the facilities/area(s) we use for basketball training, activities, service projects, etc. Please treat the facility, school, community area, people/staff, etc., respectfully. Everyone is responsible for staying in good favor with these entities so that we can keep using their facilities, etc. Please represent Sandcreek 6 LLC (SC6), your family, and yourself with dignity, class, and self-respect.
2. SC6 is committed to teaching your student-athlete, referred to as a participant, to the best of our ability. We consider the gym as a classroom. Please do not let your other children, family members, or yourself be a distraction. SC6 staff reserves the right to dismiss any participant from an SC6 event. Furthermore, SC6 reserves the right to ask anyone to leave an SC6 event, e.g., basketball camps, training, **dismissal from club teams**, or any other SC6 event or activity.
3. Our mission at SC6 is to develop each participant in the game of basketball. Each participant is a valued member of the SC6 program and will play a vital role in the program. Not all functions involve playing time. Further, equal playing time is not guaranteed and likely will not occur. Development should be the concern and focus. Regardless of the amount of playing time each participant receives, each participant should give their best effort to be a good teammate and member of the community. We will not be successful otherwise.
4. By participating in SC6 events and activities, you certify that your participant is healthy and can participate in athletic activities. You are aware that significant risks and hazards are involved in all aspects of athletic training, including injury and death due to negligence on the part of your participant. You, at this moment, assume full responsibility for any harm or death that may result from your participant's participation in Sandcreek 6 events and activities. As a result of this, **I release Sandcreek 6 LLC (SC6), SC6 coaches or staff, and facility owners from any liability, claims, demands, actions, club team financial reimbursement if the player is dismissed or rights of action which are related to, arise out of or are in any way connected with my participation in the activity with SC6 events and activities, including those allegedly attributed to the negligent acts or omissions of participants.** This waiver shall bind you and your participant's successors, representatives, heirs, executors, assignees, or transferees.
5. You accept full financial responsibility for any injury your participant may cause to SC6 staff or any participant due to your or your participant's negligence or malfeasance. Should SC6, a participant, or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this waiver, you agree to reimburse them for such fees and expenses.
6. I understand that SC6 does not favor one player over another. We give each player the same opportunity to make an Idaho school district basketball team. SC6 holds no favoritism or

decision on who may or may not make an Idaho school district sports team. SC6 is not affiliated with Sandcreek Middle School, Hillcrest High School, District 93, or any school district.

Sickness Guidelines

- Parents will screen their participants before every Sandcreek 6 activity. Suppose a participant is not feeling well or exhibits any symptoms below. In that case, parents will not have their participants participate in the activity.
 - ❖ Fever (100.4 degrees or greater), cough, shortness of breath, chills, headache/unusual headache, loss of taste or smell, muscle aches, sore throat, fatigue, congestion/runny nose, GI symptoms (nausea, vomiting, diarrhea, loss of appetite).
- Parents will have their participants sanitize their hands before every Sandcreek 6 activity.
- Each participant will bring and use their water bottle to Sandcreek 6 activities.
- Each participant will bring and use their basketball to games, camps, practices, and open gyms.
- Parents and other family members should limit their attendance at practices, shooting clinics, and speed and agility sessions.
- We will follow all guidelines and protocols of District 91/93 or other facilities used by Sandcreek 6.
- Parents, family members (and participants outside of activities) will maintain social distancing and wear face coverings when required.
- Parents are encouraged to take other precautions necessary for the health and well-being of themselves, their families, and their participants.
